Short-Time Compensation Purpose: Short-Time Compensation (STC), also known as work sharing or shared-work program, is an alternative to layoffs for employers experiencing a reduction in available work STC preserves employees’ jobs and employers’ trained workforces during times of lowered economic activity

State Telephone INSTRUCTIONS: When 25 or more employees in one establishment are separated on the same day, for the same reason, and the separation is permanent, for an indefinite period or for an expected period of seven days or more, complete this form, and the Mass Separation List of Workers (DOL-402A). A separate list should be completed.
